 - the products which are being purchased in this transaction are for your non-commercial use; and
 - you have not taken advantage of more than one other Apple educational discount in the past 12 months (in other words, you have not signed more than one of these agreements (other than this one) in the past 12 months).
5. By providing a telephone number and/or email address below, you authorize Apple to contact you for the purpose of proving your status as a Qualifying Individual. Not all those who provide details will be contacted - Apple will only contact sufficient numbers to ensure that the education discount scheme operates properly.
